#### MHAA Treasurer's Report for September 2022

As of 19 September 2022 we have \$4198.52 in our bank account and \$1212.72 in our PayPal account, with the Treasurer holding \$40 in petty cash. Our monthly Zoom subscription of \$14.99 was paid automatically via PayPal on the 15th, as always.

Since last month's report we have received \$75.44 for one new membership and two renewals. With PayPal's revised service fee we receive an extra 22 cents when someone pays \$26 for membership via PayPal, compared to losing 24 cents as we did before.

As reported a few months ago I repaired the internal power supply for the club's ETX-125 so that it could run off of batteries. (It was working fine via an external 12V connection.) It takes 8 AA batteries and I noticed that they did not last very long, so I purchased a set of rechargeable batteries and a charger that will now go with that scope, for a cost of \$28.80, which I reimbursed to myself via PayPal.

#### MHAA - 2 - September, 2022

We are now receiving monthly invoices from Google for the storage we use for the club "Datastore," though the charge has been zero. They will start charging us soon, but the fee should be minimal, and we now have some guarantee that our data will be preserved. Meanwhile, I regret that with the start of the school year I have not been able to do further research on securing a non-profit letter of determination from the IRS. I hope to get back to that soon.

## MHAA Membership Account management status

The members in elected roles completed the beta test run of setting up new accounts on the website that will manage their membership and grant access to members-only content/features. The test resulted in some minor tweaks to the instructions based on their experience, but by and large it was a success. I plan to send out codes to the regular members, so they can do the same, in early October.

## **Google Workspace Account**

Google requires us to convert from our free workspace account to a paid business account. This introduces a monthly bill in the ball park of \$20.

We hope to convert to a non-profit account within a few months, which will make it free again, but I confirmed with the IRS that we are not officially registered as a 501(c)(3) org even though some members thought we were. We'd been operating under the belief that we were when it came to our by-laws and filing the tax postcards, etc, so we should only need tiny tweaks, if any, to our existing procedures to qualify. Eric is working on sorting out any changes and filing the paperwork.

As a bonus, once we have the Determination Letter from the IRS confirming our status, we can enroll in Bing Rewards

and Amazon Smile as eligible recipients of user micro-donations (through their searches and purchases etc) as I'd brought up a few months ago."

## MHAA Treasurer's Report for July 2022

As of 17 July 2022 we have \$4,354.20 in our bank account and \$1343.31 in our PayPal account, with the Treasurer holding \$40 in petty cash. Our monthly Zoom subscription of \$14.99 was paid via PayPal on the 15th of the month, as it always is. Around that same time our 6 month bill for Meetup.com was charged to my credit card for \$106.86, and I have reimbursed myself via PayPal.

Since last month's report we have received \$99.52 for two new memberships and two renewals. We received a donation of \$100 from Vineyard Commons in Highland, where we had a delightful event on June 3rd. I am afraid I forgot to mention in last month's report that when long time member and club founder David Lindemann renewed his membership he included an additional donation to the club of \$25. Thank you David, both for the contribution now, and for your contributions back when we were getting started.

I have received notice from PayPal that they are changing their terms of service (as they sometimes do) and that includes their fee structure. They have been taking out a fixed fee for every transaction, plus a percentage of the amount of the transaction. For someone who pays dues of \$26.00 via PayPal, they take \$1.24 and we get slightly less than \$25. Their new system will do away with the fixed fee and just charge 2.99% of the transaction amount. That should lower our fee so that we will get slightly more than \$25 instead, so this is in our favor.

They are also changing their terms so that a U.S. Business (that's how they view us) cannot receive money from "friends" without the transaction fee. In the past it was possible for someone to pay dues via PayPal of only \$25 but check a box that said something like "sending to a friend," and we would get the whole \$25. I have not publicized this, because it might be confusing to people, and as we now see, it is going away. I don't think they are removing the path which lets us send money without a fee to a personal account. That is how I pay back myself and others for expenses we've paid for initially out of our own pockets. I'll keep an eye on this — it will be important after the picnic.

This coming weekend we will have our first (annual, we hope) club picnic, at the Field of Dreams Park outside of New Paltz (near the Fairgrounds). At a previous meeting we voted to pay for some of the expenses, but we later realized that we should also ask people to help with the expenses, to avoid any possible question of our status as a 501(c)(3) organization for federal tax purposes. The club has alread paid \$100 to the Town of New Paltz to rent the shelter. The organizers will pay for food and drink and collect money from those in attendence, and we'll sort it out afterwards and I'll pay back the organizers after the event.

I'm afraid I have not made any significant progress since the last report on filing IRS Form 1023-EZ to secure a definite determination of our tax exempt status. According to our Webmaster we have a few months until Google starts charging us, and they will not delete our files, so we are not in danger of great damage. I also don't think the IRS will give us a letter of determination right away. Still, it's best to get it into their hands soon, so I hope to make progress on it in the next month.



## The Summer Triangle's Hidden Treasures

September skies bring the lovely **Summer Triangle** asterism into prime position after nightfall for observers in the Northern Hemisphere. Its position high in the sky may make it difficult for some to observe its member stars comfortably, since looking straight up while standing can be hard on one's neck! While that isn't much of a problem for

those that just want to quickly spot its brightest stars and member constellations, this difficulty can prevent folks from seeing some of the lesser known and dimmer star patterns scattered around its informal borders. The solution? Lie down on the ground with a comfortable blanket or mat, or grab a lawn or gravity chair and sit luxuriously while facing up. You'll quickly spot the major constellations about the Summer Triangle's three corner stars: Lyra with bright star Vega, Cygnus with brilliant star Deneb, and Aquila with its blazing star, Altair. As you get comfortable and your eyes adjust, you'll soon find yourself able to spot a few constellations hidden in plain sight in the region around the Summer Triangle: **Vulpecula the Fox, Sagitta the Arrow**, and **Delphinus the Dolphin**! You could call these the Summer Triangle's "hidden treasures" – and they are hidden in plain sight for those that know where to look!

**Vulpecula the Fox** is located near the middle of the Summer Triangle, and is relatively small, like its namesake. Despite its size, it features the largest planetary nebula in our skies: M27, aka the Dumbbell Nebula! It's visible in binoculars as a fuzzy "star" and when seen through telescopes, its distinctive shape can be observed more readily - especially with larger telescopes. Planetary nebulae, named such because their round fuzzy appearances were initially thought to resemble the disc of a planet by early telescopic observers, form when stars similar to our Sun begin to die. The star will expand into a massive red giant, and its gasses drift off into space, forming a nebula. Eventually the star collapses into a white dwarf – as seen with M27 - and eventually the colorful shell of gasses will dissipate throughout the galaxy, leaving behind a solitary, tiny, dense, white dwarf star. You are getting a peek into our Sun's far-distant future when you observe this object!

**Sagitta the Arrow** is even smaller than Vulpecula – it's the third smallest constellation in the sky! Located between the stars of Vulpecula and Aquila the Eagle, Sagitta's stars resemble its namesake arrow. It too contains an interesting deep-sky object: M71, an unusually small and young globular cluster whose lack of a strong central core has long confused and intrigued astronomers. It's visible in binoculars, and a larger telescope will enable you to separate its stars a bit more easily than most globulars; you'll certainly see why it was thought to be an open cluster!

Delicate **Delphinus the Dolphin** appears to dive in and out of the Milky Way near Aquilla and Sagitta! Many stargazers identify Delphinus as a herald of the fainter water constellations, rising in the east after sunset as fall approaches. The starry dolphin appears to leap out of the great celestial ocean, announcing the arrival of more wonderful sights later in the evening.

Want to hunt for more treasures? You'll need a treasure map, and the Night Sky Network's "Trip Around the Triangle" handout is the perfect guide for your quest! Download one before your observing session at <u>bit.ly/TriangleTrip</u>. And of course, while you wait for the Sun to set - or skies to clear - you can always find out more about the objects and science hidden inside these treasures by checking out NASA's latest at <u>nasa.gov</u>.

## **Directions To The Star Party Site**

Lake Taghkanic State Park is in the town Ancram, NY. The park entrance is on the Taconic Parkway 10 minutes north of the exit used for Wilcox park.

Star Parties at Lake Taghanic are held in the West Parking lot, next to the beach. The skies are darker than in Wilcox, with less stray light to deal with. The horizon is also much lower, especially to the south and east, making many more targets possible.

**IMPORTANT:** all events at Lake Taghkanic State Park require an **RSVP** which includes license plate number of the car you are bringing (please do so via <u>Meetup</u>). The park is patrolled by state police, and all non registered cars will be ticketted and risk our use of the park.

# General Information:

• Dates listed for star parties are the primary dates. The rain date is the following night unless otherwise noted. Only one session is held for a given weekend, usually on the primary date, Friday, unless postponed (usually due to inclement weather) to the backup date, Saturday. Exceptions to this are noted in the "Scheduled Events" section above.

• All outdoor events are FREE! All are welcome. If you bring small children, it is <u>your</u> responsibility to keep a close eye on them. Please do not bring white-light flashlights. Instead, bring a red astronomer's flashlight or an ordinary flashlight covered with several layers of red cellophane. If in doubt about the weather, check the status of the event at <u>www.midhudsonastro.org</u>.
